The good news is that this reorganization was accomplished largely through the use of existing positions and only a minimal amount of new funding was utilized.

I am pleased to update you on the changes that have occurred in the Human Resources Department. After three years of service to San Bernardino Valley College, Julia Sanchez, Human Resources Generalist resigned effective September 4, 2015. Deneatrice Lewis, who has served as the Recruitment Specialist for the district has accepted a promotion to HR Generalist to replace Julia.

SBVC will have an additional generalist, Cecilia Andrada to support the campus. Karla Trujillo will continue to support Crafton but will

relinquish her duties of the District office, Police, TESS, EDCT, and KVCR to the new generalist Erica Mosley. All positions that impact each campus and department will be handled by each respective generalist. These duties were previously handled by HR Technicians, titles that have been replaced with HR Generalists.

The department has also made changes to the two (2) recruitment placement specialist positions with the creation of one primary recruiter for the district. Janet Penn is the

STATE CHANCELLOR'S ACCREDITATION TASK FORCE

The State Chancellor's Office just released the report of the Accreditation Task Force. In recent years, serious concerns about our regional accreditation agency have surfaced, warranting a formal assessment and set of recommendations. The charge of the task force was to evaluate the current state of accreditation of community colleges California and to recommend possible courses of action that would best serve students within the 113-college system. The task force also considered whether an accrediting commission that solely accredits two-year institutions is best suited for colleges as they expand their mission.

According to a June 2014 State Audit Report of California Community College Accreditation, between 2009 and 2013 the ACCJC's sanction rate was 53 percent, compared to 12 percent sanction rates within the other six regional accreditors. The quantity and frequency of sanctions issued by the ACCJC have led to repeated calls for reform of the accrediting process from member institutions. Between February 2005 and July 2015, all but 37 of the California community colleges were placed on some level of sanction, two-thirds of the total colleges in the system. These numbers are inordinately high compared to the frequency of sanctions under other accreditors. Additionally,

the community college system is transitioning into one that offers the bachelor's degree on a limited basis.

The task force concluded that the structure of accreditation in this region no longer meets the current and anticipated needs of the California Community Colleges. Furthermore, the task force concluded that several past attempts to engage with the ACCJC to make the accreditation process more effective and collegial have yielded very little in the way of progress. Simply put, the task force concluded that the California Community College system and its member institutions have lost confidence in the ACCJC and that change is needed.

The recommendation is to develop a plan by spring 2016 to begin transitioning California community colleges to a different accrediting body.

The next step is for Chancellor Harris to bring the report to the system's shared governance body (Consultation Council) for discussion. In September, the report will be discussed as an informational item at the Board of Governors' meeting in Sacramento. If direction is eventually given to transition colleges to a different accreditor, the process could take up to 10 years to complete.

SEARCH FOR VICE CHANCELLOR BUSINESS & FISCAL SERVICES CONTINUES

The Board approved the extension of the Interim Vice Chancellor of Business & Fiscal Services to the end of this year to allow us to begin another search process. You might



recall, our latest search failed to produce a candidate suited for the position. In addition, the committee was not properly constituted per administrative procedure #7250 because two members of the search committee who had the most relevant knowledge about the specific needs of the position in terms of technical, managerial and interpersonal skills were out ill.

A new process is underway and three finalists were interviewed last Friday. It is expected that a decision will be announced shortly.

EDUCATIONAL AND FACILITIES MASTER PLANNING

The District published a Request for Proposals (RFP) on June 8, 2015 in order to help the campuses update the Educational and Facilities Master plans and to create a report as a District. We received very strong proposals and based on experience and contractor presentations, we have moved forward with HMC Architects who is partnering with Alma Strategies to assist with the planning processes.

The intent of the Educational Master Plan is to assess the external and internal environment at SBCCD and to provide recommendations on instructional and support programs that will meet the changing needs of the community. The objective of the Educational Master Plan is to identify current and future programs of instruction and support services. SBCCD's program review, District Strategic Plan, and established collegial governance processes are important factors in the development of the Educational Master Plan. The Educational Master Plan shall provide a foundation for the Facilities Master Plan.

The purpose of the Facilities Master Plan is to establish the short and long-term facilities needs of the District based on the Educational Master Plan. The objective is to determine current and future space needs, identify the building/facilities required, establish building facilities priorities, formulate project costs, and recommend a resource allocation plan for the district.

While SBCCD has the internal capacity to develop some of the required components of the Educational and Facilities Master Plans, the goal is to produce District-wide plans that expand and enhance what the District is able to develop, while working through college collegial processes.

DISTRICT ACCREDITATION ACCOMPLISHMENTS

The ACCJC Ad Hoc Task Force reconvened on September 3, 2015 after a relaxing summer break to review the purpose of the task force, provide clarity and agree to the scope of the process, agreed to the goals of the task force, review the progress of District recommendations, and to discuss the steps they will take for the recommendations.

I appreciate the work of the ACCJC Ad Hoc Task Force, who has worked to answer the following questions for each District-level recommendation:

- What triggered the findings?
- What needs to be done to address the findings?
- What evidence will we provide and in what format?
- What are the necessary resources?

working draft Response Team Recommendations and the Commission Action Letter for District Recommendations was developed. The document describes the resolution of each recommendation, analyzes the results achieved to date, provides evidence of the results, and indicates additional plans that have been developed. Nothing is more important than preparing the accreditation follow-up report. I believe we are headed in the right direction and when the report is completed, it will show the ACCJC that we have done the hard work and deserve to be taken off of sanction. The ACCJC Ad Hoc Task Force will meet again in December and updates will continue to be shared district-wide.

ACCOMPLISHMENTS OF THE ECONOMIC DEVELOPMENT & CORPORATE TRAINING DEPARTMENT

Dr. Matthew Isaac, Associate Vice Chancellor EDCT has provided an update of accomplishments for the month of September.

Workforce Development

- EDCT is selected to receive Authorized Center (MAC) Award from Manufacturing Skill Standards Council (MSSC). This award is given to schools and centers in the nation that are leaders in assessing individuals for MSSC industry-recognized nationally portable certifications and providing exemplary service in creating a better workforce pipeline.
- Pre-Apprenticeship Construction Training program initiated. Funding



identified and initial budget developed. Instructor/Trainer and Professional Expert/Coordinator for the Pre-Apprenticeship are recruited. Program will be launched in January 2016.

- In September, EDCT-PDC conducted 7 off-site training programs and held 4 classes at the PDC. A combined total of 171 incumbent workers from 19 different companies were trained this month.
- The first training in Mechanical Craft funded by the TAACCCT grant for a cohort of 18 trainees began in September. Incumbent workers from six companies are participating in this 136hour training, including Excel Logistics, California Steel Industries, Leggett & Platt, TST Inc., 3M, and Fender.
- Our project with Amazon.Com was launched. Beta testing of employees for the purpose of designing a customized training program started on September 22, 2015.

Entrepreneurship Institute of San Bernardino (EIOSB)

With of **EDCT** the assistance Foundation, a partnership is being developed by EIOSB with the City of San Bernardino to offer micro loans from City's Community Development Block (CDBG) grant for eligible participants who complete Entrepreneurship training.

Regional Office of Information Communication Technology/Digital Media (ICT Digital Media)

 Office of the ICT Digital Media continued to provide Cyber Security leadership through the month of September that resulted in planning a Cyber Symposium for 200-400 K-12 and community college faculty and administrators. The Symposium will be offered on October 15, 2015 at the National Orange Show Events Center Valencia Room in San Bernardino.

Education (CTE) Community Collaborative

- \$40,000 contract has been given to the EDCT's CTE Community Collaborative program by the Mount San Jacinto College from its SB1070 funding to coordinate the 8thAnnual Counselor Conclave. The Counselor Conclave provides professional development and a forum for middle, high, and community college counselors to share their best practices. The Eighth Annual Counselor Conclave will be held on Monday, November 2, 2015 at the Riverside Convention Center.
- Wendy Zinn, EDCT Manager of the CTE Community Collaborative, was inducted as a founding member of the Global STEM Leadership Alliance (GSLA) Advisory Board.

EDCT Foundation

- The EDCT Foundation developed a program implementation plan to coordinate and offer microloans to entrepreneurs, using City of San Bernardino's CDBG grant. The plan is developed and submitted to the City Manager by the EDCT Foundation on behalf of the EIOSB for approval.
- EDCT Foundation's Tax Exempt 501c3 application was approved by the US



Department of Treasury and is awaiting the final Letter of Approval.

- A Chinese Delegation visit and lecture was hosted by the EDCT Foundation.
- A Holiday Gala Event for the regional companies we do business with is being planned by EDCT Foundation.

LOCAL TAXPAYERS TO SEE A \$10,700,000 IN SAVINGS

The San Bernardino Community College District (SBCCD) is proud to announce its most recent initiative to benefit its students and community members. This initiative will deliver bond interest rate savings to local taxpayers from the refinancing of a portion of the District's Election of 2002 Measure P Bonds.

The Board of Trustees and District administration chose to take advantage of historically low interest rates to refinance bonds from its Measure P authorizations without extending the term of those bonds. The District was able to reduce the interest rates on the prior bonds from an average of 5.00% to 3.54%, reducing the community's tax bill by a total of \$10,705,677.64 over the life of the refinancing.

John Longville, President of the SBCCD Board of Trustees, said, "The SBCCD Board of Trustees and District administration recognize their fiscal and fiduciary responsibility to save our community money and are pleased to be able to save the taxpayers such a substantial amount over the life of these bonds."

Chancellor Bruce Baron said, "We will continue to monitor the financial markets in order to be able to take advantage of any similar opportunities that might become available. We are particularly proud of the fact that such recognized credit rating services as Moody's and Standard and Poor's gave our District high ratings for consistently good financial practices."

The District's ability to obtain these low interest rates and achieve these high savings levels was boosted by its credit ratings of "Aa2" assigned by Moody's Investors Service and "AA-" from Standard and Poor's, which reflect the District's 1) large property tax base, 2) stable finances and strong reserves, and 3) good financial management policies. These strong ratings allowed the District to attract a great deal of investor interest and obtain excellent interest rates on the date of bond refinancing.

While the District will not receive any part of the savings, the District Board and District Administration pursued this opportunity strictly on behalf of local taxpayers as part of their continued support for the education of the students of its community. This was the second time that the San Bernardino Community College District took the initiative to deliver savings to its community. In April 2013, the District did a similar bond refinancing and saved local taxpayers a total of \$11.5 million.

DISTRICT BUDGET COMMITTEE RELEASES 2014-15 ANNUAL REPORT

GOVERNOR BROWN SIGNS AB 288

Just last week, Governor Brown signed Assembly Bill 288 (Holden), the College & Career Access Pathways (CCAP) Act. Governor Brown, members of the California Legislature, and the supporters of AB 288, support and understand that early access to college and career opportunities is a priority.

AB 288 is the vehicle for long overdue reforms to California's dual/concurrent enrollment laws. These reforms will provide greater access to college, improve time-to-completion, and save families on the total cost of college.

AB 653 GOES INTO EFFECT JANUARY 1, 2016

The Governor signed AB653 (Levine) into law last week. The bill goes into effect on January 1, 2016 and makes contracting practices among the segments of higher education more efficient by improving the ability of community college districts to share contracts with University of California (UC) and California State University (CSU). Specifically, AB 653 adds clarifying language to statute, which specifies that districts can share, "piggyback," onto contracts with UC and CSU for the purchase of goods and services. This will provide for more efficient contracting practices and potential cost savings to all three segments. A link to the bill is provided below:

All regular and special meetings of the Board, except as otherwise required or permitted by law, are open to the public so that citizens may have the benefit of Board deliberations concerning items under consideration.
