District's New Risk Management Coordinator

Maria Ramirez is the new Risk Management Coordinator, joining the Safety & Risk Management division, in Human Resources, as the newest team member.

Maria will work with Whitney Fields, the Director, Safety & Risk Management and will be tasked with updating safety programs, conducting accident/incident investigations, working with the new online safety training database and conducting routine safety inspections/audits, at both college campuses and the district-site locations.

Ms. Ramirez brings a wealth of experience to the district and will assist in ensuring compliance with local, state and federal regulations. Maria grew up in El Monte, California and upon graduation she joined the United States Marine Corps where she served over four years of active duty in the Safety, Logistics and Training offices. She worked for the Marine Corps as a Civil Servant at Marine Depot Maintenance Command (MDMC). She, and her team, rewrote MDMC's State and Federally mandated Occupational Health and Safety programs. The MDMC went from being #1 on the Department of Defense's injury list, to having zero recordable injuries in a month. Her experience as a Risk Manager for a local school district afforded her the knowledge of the Education Code and how it intertwines with Federal and State regulations. Maria has a passion for the safety field and has learned that safety is a culture; it is a way of thinking and living.

We are excited to have Maria on board and she is excited for this opportunity and looks forward to her time at SBCCD.

Renovations to Begin at PDC

The Professional Development Center (PDC) facility opened its doors in 2002 and is overdue for maintenance work and classroom upgrades. After soliciting proposals from various contractors through a formal process, a final contractor was selected to perform the repair work. The renovation of the facility will include painting the internal walls, industrial grade cleaning of the restrooms and carpets, installing LCD Projectors and projector screens in the classrooms, new furniture for Classroom 101, electrical wiring for Classrooms 101 and 102, and re-configuration of the existing furniture layout in Classroom 102. The renovation project is expected to begin on February 16 and be completed by the end of March 2016.

Transparency Through Commitment, Communication, and Technology

SBCCD strives to maintain a culture of openness and transparency in its internal operations, with all of its constituent groups. We recognize the ongoing responsibility to improve communi-

cations and have embraced the need to create better communications among all campus stakeholders. One example is with the bi-monthly Chancellor's Chat distribution to all users on the global distribution list. Later this month we begin "Breakfast with Bruce" where representatives from each campus are selected to have breakfast and meet informally with the Chancellor to discuss needs, issues, and to communicate updates district-wide. On March 23 from 12:15-1:00pm, we are scheduled to kick-off a "Chancellor's Chat Live" webcast where everyone is invited to have discussions with the Chancellor and Vice Chancellors.

Board of Trustees

The Board of Trustees of the San Bernardino Community College District is the governing body of the District. The Board is established by, and derives its power and duties from, the Constitution of the State of California and the Statutes of California as adopted by the Legislature and issued in the California Education Code, and the directives of the Board of Governors, California Community Colleges, listed in Title V, California Code of Regulations.

Seven trustees, elected from your communities, and two student representatives elected by their respective campuses govern the San Bernardino Community College District. Trustees serve a four-year term, while the non-voting student trustees serve a one-year term.

All regular and special meetings of the Board, except as otherwise required or permitted by law, are open to the public so that citizens may have the benefit of Board deliberations concerning items under consideration.
