### Enrollment Update 2015-2016

After months of planning and meeting with the college presidents about the importance of meeting our enrollment goals for 2015-2016, we are currently falling short of our goal by about 1,700 FTES. If you recall, the new state funding formula allocated additional growth funding to this region because of it depressed economy and low college going rate. Our goal for this year is 10,500 FTES. We still have summer session, which we hope will bring in over 900 FTES, we still need to make-up that gap through the remainder of this spring semester. The colleges are working on additional late-start classes, additional classes at the high schools along the AB288 model, additional positive attendance, and other enrollment increase methods. We will have to wait and see how close to this goal we can get.

# The Institutional Effectiveness Partnership Initiative Update

On March 31, 2016, the State Chancellor's Office will be assisted by a team of subject-matter experts, who are peers from other colleges around the state. They will be working with SBCCD staff to analyze the improvements that we have made since the ACCJC recommendations last year. We are looking forward to validation of the work that we have undertaken to make system improvements and learning about any additional ideas that can be brought into operation. The District will be eligible to receive a grant of \$150,000 for its participation in the program.

#### EDC7 Update

A delegation of Chinese educators and provincial educational administrators from Gansu Province, China, received a whole-day training at the Donald F. Averill Applied Technology Training Center (ATTC) on February 26, 2016. The topics covered in their customized training program included: 1) Building Career Technical Education (CTE) Pathway from K-12 to community colleges, 2) How US colleges prepare students for industry licensing in Applied Technologies, Mechanical Design and Transportation, and 3) National Skills Testing: A General Overview.. Fourteen individuals, including professors, directors, and a Director General of the Gansu Province, attended the specially designed training program offered on contract by EDCT.

#### Workforce Development

In February, the Employment Training Panel (ETP) program trained 301 incumbent workers from 30 different com-

- panies. Eight (8) off-site and 11 on-site classes were offered to incumbent workers which brought the performance level of the program to 95%.
- The Professional Development Center's (PDC's) contract with the California Manufacturing Technology Consortium (CMTC) was extended by one quarter for \$15,000 and EDCT is considered to be written into CMTC's new grant proposal.
- The EDCT's Trade Adjustment Assistance Community College and Career Training (TAACCCT) project has completed its first Mechanical Craft training. Twelve participants received 136 hours of training.

Career and Technical Education (CTE) Community Collaborative

 As a result of the successful delivery of curriculum design and professional development in Nanotechnology for the teachers of the Norton Elementary School for two years, the Norton School through the San Bernardino City Unified School District is now in the process of contracting with the EDCT's CTE Community Collaborative department to offer Aquaponics/ Hydroponics program. The EDCT CTE Community Collaborative is being contracted to offer this program for \$25,000.

Economic Development and Corporate Training Foundation (EDCT Foundation)

- The EDCT Foundation submitted grant proposals to Walmart Foundation, Bank of America Foundation, and to the Tourism/Retail/Hospitality Sector Navigator.
- Ashley Gaines is currently developing partnerships and preparing a proposal in order to apply for a \$5 million Tech Hire Grant in collaboration with the Los Angeles Community College District.
- The EDCT Foundation secured funding for the Chair of the Foundation Board and the Director of the Foundation from the Annenberg Alchemy to attend their Leadership Seminar.

### Board of Trustees

The Board of Trustees of the San Bernardino Community College District is the governing body of the District. The Board is established by, and derives its power and duties from, the Constitution of the State of California and the Statutes of California as adopted by the Legislature and issued in the California Education Code, and the directives of the Board of Governors, California Community Colleges, listed in Title V, California Code of Regulations.

Seven trustees, elected from your communities, and two student representatives elected by their respective campuses govern the San Bernardino Community College District. Trustees serve a four-year term, while the non-voting student trustees serve a one-year term.

All regular and special meetings of the Board, except as otherwise required or permitted by law, are open to the public so that citizens may have the benefit of Board deliberations concerning items under consideration.
