Relationship "Domestic" Violence

One out of every four women in this country will suffer some kind of violence at the hands of her husband or boyfriend. Men. straight and gay, and lesbians can also be victims of violence. Few of these victims will tell anyone about the violence. Relationship violence victims come from all walks of life. They do, however, share the same feelings of helplessness, isolation, guilt, fear, and shame. They all hope it will not happen again, but often it does. Here is what you can do if you are the victim of relationship violence,

the victim of relationship violence, dating violence, domestic violence, harassment, or stalking: Talk to someone. Part of the abuser's power comes from secrecy. We urge you to talk to someone about the violence..

Sexual Assault Awareness

There is no perfect way to protect yourself, but there are simple things you can do to minimize your risk. Do not let alcohol or other drugs fog your judgment Be alert. Show that you are in control. Walk with confidence. Be aware of your surroundings. Be assertive. Do not let anyone violate your space. Avoid walking or jogging alone. Use well-traveled and well-lit areas. Use the campus escort service.
