13th Nationwide Prescription Drug Take Back Day Saturday, April 29nd from 10am to 2pm

The San Bernardino County Sheriff's Department in partnership with the Drug Enforcement Administration (DEA) will give the public its 13th opportunity in six years to prevent pill abuse and theft by ridding their homes of potentially dangerous, expired, unused, or unwanted prescription drugs. Bring your pills for disposal on Saturday, April 29th from 10 a.m. to 2 p.m. to any one of the below listed collection sites. The service is free and anonymous, no questions asked.
