

New ShakeAlert Earthquake Early Warning App Available for 2019

If you find yourself in or near Los Angeles County, be advised the City of Los Angeles has released a new ShakeAlertLA mobile app that sends alerts to users within Los Angeles County that an earthquake of greater than magnitude 5.0 or level IV intensity has been detected and that users may soon feel shaking. The app is available for both Apple and Android devices and available in both English and Spanish. You can also use this app to prepare for an earthquake, get details on recent earthquakes, and find help after an earthquake.

New California Laws for 2019

SB 1046 -- DUI: Ignition Interlock Device

From January 1, 2019 to January 1, 2026, this law mandates repeat offenders for driving under the influence (DUI) and first DUI offenders whose violations resulted in injury, to install an ignition interlock device (IID) for a period ranging from 12 to 48 months.

This law also allows those who receive a suspension under the Administrative Per Se law to obtain an IID-restricted driving privilege, and receive credit toward their required IID restriction period if they are



later convicted of a DUI. These provisions apply to DUI violations that involve alcohol or the combined use of alcohol and drugs. They do not apply to drug-only violations. Additionally, courts have the discretion to order a non-injury first DUI offender to install an IID for a period of up to 6 months. If the court does not order IID installation, a non-injury first offender may apply for a driver license for IID restrictions or restrictions that allow them to drive to, from, and during their employment and to and from a DUI treatment program for 12 months.

AB 3077 -- Bicycle Helmets

Anyone younger than 18 not wearing a helmet on a bicycle, scooter, skateboard or skates will be issued a "fix-it" citation. If the minor can show they took a bicycle safety course and has a helmet that meets safety standards within 120 days, the citation will be non-punishable.

AB 2989 -- Helmets and Motorized Scooters

Helmets are no longer required for motorized scooter riders over 18 or older. Motorized scooters are also allowed on Class IV and Class II bike paths. It is still illegal to ride a motorized scooter on a sidewalk. The law also allows scooters to ride on roads with speed limits up to 35 mph.

Minimum Wage:

The state minimum wage gets another boost to \$11 an hour for people working at companies with 25 or fewer employees, and to \$12 an hour for those working at companies with 26 or more employees.
