#### MISSON STATEMENT

The SBCCD Police Dept. in concert with the Board of Trustees, is committed to providing a safe and secure learning and working environment for all students and employees. This will be accomplished through a cooperative and coordinated effort involving all departments and the SBCCD employees, law enforcement agencies and the community.

# On January 1, 2024, various California laws relative to overall public safety and colleges went into effect. The following are a few of the most relevant laws:

AB 256: under this new law, which takes effect July 1, 2024, a violation relating to the registration sticker displayed on a vehicle's rear license plate can no longer be the sole basis for an officer to pull over a driver for enforcement action before the second month after the expiration of a vehicle's registration.

AB 257: increases California's minimum wage to \$16 an hour effective January 1, 2024. State law requires that the state's minimum wage go up annually by either 3.5% or inflation as measured by the U.S. Consumer Price Index, whichever is less. There are even higher wages due to come into effect for fast food workers and healthcare workers.



<u>AB 531</u>: will result in the issuance of \$6.38 billion in bonds to fund 11,150 new behavioral health beds and housing as well as 26,700 outpatient treatment slots.

<u>AB 607</u>: requires the California Community College (CCC) and California State University (CSU) systems to "prominently display" the estimated costs for each course on the campus course schedule. The estimated cost will include all course materials, including digital and physical textbooks, calculators, and software subscriptions needed for successful class participation.

<u>AB 645</u>: allows six cities - Glendale, Long Beach, Los Angeles, Oakland, San Francisco and San Jose to install speed cameras. The law requires these cities to put up signage warning drivers they could get a ticket if they don't slow down before approaching the speed cameras.

<u>AB 2188</u>: makes it unlawful for an employer to not hire, penalize, or terminate a person based on their use of cannabis products outside of work. Specifically, workers in California who use marijuana will have new protections when using the drug off the job and away from the workplace.

<u>AB 2773</u>: pursuant to this new law, California law enforcement officers will no longer be able to start a traffic stop by asking the question: "Do you know why I pulled you over?" Instead, the officer must state the purpose of the stop before asking any other questions. Same goes for interactions with a pedestrian. Other state lawmakers who supported the bill said it will also help limit an officer's ability to make "pretextual stops," or stops that are used as an investigative tool for something completely unrelated to the actual reason for a driver being pulled over.

**<u>SB 14</u>**: increases the penalties for human trafficking of minors in California. The law designates human trafficking of a minor for purposes of a commercial sex act as a serious felony.

<u>SB 142</u>: allows community college districts that contract with CalPERS for health benefits to extend health care eligibility to part-time faculty.

<u>SB 326</u>: reforms the Mental Health Services Act—making better use of Mental Health Services Act funding to address today's needs and increasing accountability to the public.
