Police Tips for Guarding Against Sexual Assault

April is Sexual Assault Awareness

Protect yourself from sexual assault

Acquaintance rape is a rape committed by someone known to the victim. This might be a friend, classmate, co-worker, instructor, relative, or casual acquaintance such as clerk in a store. It is important to remember that Acquaintance is not a separately defined crime. Any person, whether an acquaintance or not, who compels a person to submit to sexual intercourse against his or her will, by force or by threat of bodily injury, commits the crime of rape.

Women are more likely to be sexually assaulted by a person known to them than by a stranger. In one survey, most of the college women who had been raped knew their attacker, and the attacker was the woman's date in more than one-half of the rapes.

Victims of acquaintance rape are often involved in situations where they trust their acquaintance not to be an assailant. Some assailants foster a false sense of friendliness in order to sustain a level of trust in their intended victim.

- Communicate clearly what you want, and what you're expectations are.
 - Set limits for acceptable sexual behavior.
 - Trust your instincts.
 - Learn to be assertive.
 - Say "NO," and mean it.
 - Be aware of your verbal and non-verbal actions.
- Leaving a party with someone you have just met could be dangerous
 - Avoid excessive alcohol in a dating situation
 - Tell someone
