Electronic Cigarettes

Electronic cigarettes (E-cigarettes) have gained popularity over the past year and seem to be the new "trend" amongst both non-smokers and traditional smokers. Although their popularity has grown, the law surrounding the use of e-cigarettes is lacking in some jurisdictions and in other areas the law is ambiguous at best. With this in mind, e-cigarette users may be confused on where they can "light-up" and where they can't. The SBCCD PD wants to clear any confusion e-cigarette users may have in regards to our smoking policy. E-cigarettes are **PROHIBITED** on District Property and fall under the same scope as regular cigarettes. This means you can be cited for smoking "e-cigs" in non-designated areas. This prohibition is outlined in the below board policy:

SBCCD Board Policy 3570 (SMOKING)

- A. Smoking of any form of tobacco or <u>NON-TOBACCO</u> products is prohibited on District grounds, in all District vehicles, at any activity or athletic event and on all property owned, leased or rented by or from the District, unless a tobacco use area has been designated.
- B. This policy allows for the establishment of procedures to comply with California Code of Regulations Government Code Section 7597.
- C. This policy and these regulations apply to employees, students, visitors and other persons who use the facilities on the campuses or centers that are part of San Bernardino Community College District.
