# Are you 21 yet? (Safety For Minors—Social Host Accountability Ordinance)

House parties are most common among students, peers, and the youth in general in San Bernardino County. Most of these are without adult supervision and done in the realms of having fun without parental sanctions. Such avenues preset the use of alcohol and illegal substance, and may often lead to excessive drinking and substance abuse. Be wary, as hosting such gatherings can lead to disastrous events.

Violation of the Social Host Accountability Ordinance is considered a misdemeanor, punishable by 6 (six) months in jail and/or a \$1,000 fine. The host of the event will be cited and charges can be civil, criminal or administrative in nature. The Social Host can also be arrested for Child Endangerment or Contributing to the Delinquency of a Minor. The ordinance is designed to address social gatherings where underage drinking is occurring by teens, often being served by a host who is not a parent. It aims to reduce, if not eliminate underage drinking as circumstances such as DUI-related crashes, rape or sexual assault, fights, neighborhood vandalism or property damages, violence and alcohol poisoning are but a few of its dangerous impacts.

Here's what you need to know about the ordinance:

- It is the duty of a social host who knowingly permits or allow a gathering on the property to take all reasonable steps to prevent the consumption of alcoholic beverages by any minor. Reasonable steps include, but is not limited to:
  - Controlling access to alcoholic beverages and controlled substances (including marijuana).
  - Controlling the quantity of alcoholic beverages and controlled substances (including marijuana).
  - Verifying the age of each person attending the gathering by checking government-issued identification.
  - Supervising the activities of all minors at the gathering.
- ♦ No social host shall allow a gathering to take place or continue on his/her private property if a minor at the gathering obtains, possess, or consumes any alcohol beverage.
- The ordinance holds the host of the gathering responsible regardless of whether the host provided the alcohol or not. They must make sure underage drinking does not occur at their gathering.

The ordinance empowers adults by sending a clear signal of one's role in fostering a healthy and safe environment for the youth. It empowers the community so as to be mindful and watchful of their surroundings beyond the confides of their homes. It empowers law enforcers as they uphold the importance of this ordinance, allowing them the ability to respond and focus on more stringent community safety issues. But even more of empowering the youth, that by abiding, it reinforces a clear and consistent community-wide message that underage drinking is unhealthy, unsafe and unacceptable.

As youth, you are entitled to have fun and enjoy the company of your friends. But be responsible for your actions. Learn self-discipline. Do not submit to peer pressure but instead wait until you become of legal age before involving yourself in adult activities. Studies have shown of the long term impacts of underage drinking and research has proven how it can adversely affect a young person's brain development. More so, it is directly correlated with the likelihood of alcohol dependency. Make the most of your time. Be involved with youth community activities to enrich and arm you as you later travel down the path of adulthood. Remember, a safe environment improves yours and your community's quality of life!
