WINTER DRIVING MISTAKES YOU SHOULD AVOID

Driving too fast

2 Failing to clear snow off the car

3 Following others too closely

Not getting your car ready

4 Overcorrecting on ice

6 Driving fatigued

Plan to stay off the road during and immediately after a winter storm, and during winter weather advisories or watches.

If driving is necessary, follow these tips to prepare for travel:

- \Rightarrow Ensure you have emergency supplies of food and water, warm clothing, and a full tank of gas;
- Try to travel during the day and not travel \Rightarrow alone;
- Stay on main roads; and \Rightarrow
- Let someone know your destination, route, and \Rightarrow expected arrival time.

Winter weather calls for different driving techniques. Follow these tips from the National Highway Traffic Safety Administration (NHTSA) to stay safe on the road, including:

- Slow down for winter driving conditions, regardless of the vehicle you drive; \Rightarrow
- Leave plenty of room between your vehicle and others; and \Rightarrow
- Avoid using cruise control in winter driving conditions. \Rightarrow
