Advisory: BE AWARE - Police warns of ongoing scams affecting citizens

SCAM ALERT:

Most of the following scams are not new to the citizens in San Bernardino County. However, citizens continue to report receiving these calls and many were unaware such a scam existed. In an effort to reach as many of our citizens as possible, we will continue sharing this information. We are asking the public's help in sharing this information with friends and family so that they recognize the scams and don't become a victim.

The newest scam to the Yucaipa area is a call from a number that caller I.D. identifies as Edison. The caller says they're from Edison and that the resident is using too much electricity and must bring their account current. The resident is then instructed to purchase a Money Pak at any store that carries one, like Walgreens or Rite Aid. This is a scam. This is not how Southern California Edison conducts business.

If any of your creditors call to collect funds like this or notify you of possible fraud on your existing account, tell them you'll call them back. DO NOT use the phone number they provide as it will go to the scammers. Locate a bill from your actual account and call them from the number provided on the bill. If you need to be directed to their fraud division, that location can transfer you. This is the safest way you know you're talking to the real company.

In another type of scam, the victim receives a phone call from a person identifying themselves as personnel of the San Bernardino County Sheriff's Department. The victim is told that a warrant has been issued for their arrest because they did not appear for jury or grand jury duty. The victim can clear up the warrant by paying a fine through one of the following methods to include, green dot cards, western union, money gram or other wire transfers.

Similar scams include persons claiming to be from or collecting on behalf of the IRS or Immigration Office. Legitima te government or bill collecting agencies will not use the above mentioned tactics to collect from you. Members of law enforcement agencies do not accept payment for outstanding warrants and do not enforce delinquencies for other government agencies, such as the IRS. If you receive one of these calls, please do not give out any personal information and do not wire any money.

If you have questions or believe you are a victim of such a scam, please contact your local Sheriff's Station.
