# SBCCD PD HOSTS "COFFEE WITH A COP'





# SBVC DSPS TRAM SERVICE

DLIC

To assist Disabled Student Programs and Services (DSPS) students better navigate around San Bernardino Valley College (SBVC), DSPS has established a courtesy tram service to provide transportation for eligible DSPS students to and from their classes.

All requesting DSPS students must have a disabling condition that limits his or her mobility documented in their DSPS file. Also, the tram service must be approved in advance by a DSPS counselor or the DSPS Director and eligible DSPS students must complete a Mobility Service Request Form. The forms are available in the DSPS office.

A total of eight (8) designated drop-off and pick-up points have been identified on SBVC campus based on both ease of access and safety for all students. As result, the DSPS tram service will not be authorized to pick up or drop off eligible DSPS students anywhere other than these designated locations.

The DSPS courtesy tram service operates Monday – Thursday, from 8:00 am to 4:30 pm, and from 8:00 am to 4:00 pm on Friday. If you have any questions regarding the DSPS tram service, please contact the DSPS office at (909) 384-4443.
