CALIFORNIA LAW: CHANGES IN 2020

AB-2: Community Colleges: California College Promise. This bill makes students who have previously earned a degree or certificate from a postsecondary educational institution ineligible for the fee waiver at a community college. This bill also authorizes institutions to deem as full time, for the purposes of eligibility for a fee waiver, specified students not enrolled in 12 or more semester units.



AB-30: Community Colleges: College and Career Access Pathways (CCAP) partnerships. This bill requires a high school pupil participating under a CCAP partnership to submit only one parental consent form and principal recommendation, and would require the Chancellor of the California Community Colleges, on or before July 31, 2020, to revise the special part-time student application process to allow a pupil to complete one application, for the duration of the pupil's participation under the CCAP partnership.

AB-59: Elections & Polling Places: College and University Campuses. This bill expands the definition of “public building,” directing county election officials to consider vote centers located on a public or private university or college campus.

AB-239: Community Colleges: Registered Nursing Programs. This bill extends the operation of existing provisions relating to admission to community college nursing programs until January 1, 2025.



AB-381: Postsecondary Education: Intimate Partner & Dating Violence. This bill identifies domestic violence centers as an eligible type of on-campus/ community-based organization to meet existing legal requirements that community college districts refer students for assistance or make services available to students, i.e. counseling, health, mental health, victim advocacy, legal assistance, and including resources for the accused, in order to receive state funds for student financial assistance.

AB-463: Community Colleges: Faculty Members - Loan Forgiveness. This bill requires the Office of the Chancellor of the California Community Colleges to develop and provide to community college districts specified materials designed to increase awareness of the federal Public Service Loan Forgiveness Program among community college faculty members.
