MISSION STATEMENT

CALIFORNIA LAW: CHANGES IN 2021

On January 1, 2021, various laws relative to driving and overall public safety went into effect. The following are a few of the most relevant laws:

- AB 2717: Unattended Children Liability Amends existing law concerning leaving children under the age of 6 unattended in vehicles. Exempts a good Samaritan who rescues an endangered child from a locked vehicle from civil or criminal liability, "if the property damage or trespass
- occurs while the person is rescuing a child 6 years of age or younger."
- AB 2285: Approaching Stationary Authorized Emergency Vehicles Establishes potential fines for motorists who do not slow down and, whenever possible, change lanes when encountering a Caltrans vehicle, tow truck, or any emergency vehicle with lights flashing on a highway. However, AB 2285 does not specify that motorists must move over if there might be conflicts with other drivers, or conditions don't allow for it. But they must slow down. Otherwise, an officer could write them a traffic citation.
- AB 2992: Expanded Leave for Crime Victims Extends job-protected leave for victims of crime or abuse causing physical or mental injury and a threat of physical injury. This law also requires companies with 25 or more employees to provide these victims with time off work to seek medical attention or psychological counseling for their injuries, participate in safety planning, or get help from other related organizations.
- Sex Offenders Registration The Sex Offender Registration Act requires a person convicted of certain crimes to register with law enforcement as a sex offender while residing in California or while attending school or working in California. This law would exempt a person convicted of certain offenses involving minors, if the person is not more than 10 years older than the minor, from mandatory registration as a sex offender, and if that offense is the only one requiring the person to register.
- SB203: Juveniles Custodial Interrogation Youths up to age 17 cannot be questioned by police or waive their rights until they have a chance to consult with an attorney. "The bill would direct a court to consider any willful failure of a law enforcement officer to allow a youth 17 years of age or younger to speak with counsel before custodial interrogation in determining the credibility of that law enforcement officer."
- SB 909: Emergency Vehicle Audible Warning Emergency vehicles can now use a distinctive "Hi-Lo" warning sound to notify the public of an immediate need to evacuate an area in an emergency under this law that took effect in September 2020.
 - AB 1775: False Reports and Harassment Making a false 911 call on the basis of discrimination of someone's race, ethnic background, gender, religion, or sexual orientation is a hate crime. Making such a call can result in a misdemeanor sentence of up to one year in jail and a fine of up to \$2,000. Additionally, this law allows the victim to file a lawsuit against the person who made the false 911 call.
