CALIFORNIA LAWS: CHANGES IN 2022

On January 1, 2022, various California laws relative to overall public safety and colleges went into effect. The following are a few of the most relevant laws:

 <u>AB 1111</u>: Requires all California community colleges to adopt a common course numbering system that ensures that similar courses at any California community college are aligned to fulfill the same transfer requirements for CSU and UC systems. - <u>AB 101</u>: With the governor's signature, AB 101 makes California the first state to require all students to complete a semester-long course in ethnic studies to earn a high school diploma.
- <u>AB 27</u>: Requires a law enforcement agency to administer a housing questionnaire for purposes of identifying homeless children and youth annually to all parents and guardians. Requires creation and posting on the website the contact information of the liaison including resources available to persons experiencing homelessness.
- <u>AB 43</u>: Gives cities new authority to reduce their speed limits. Local officials can reduce limits in increments of 5 mph by factoring the safety of pedestrians and cyclists in traffic surveys.
- <u>SB 73</u>: Ends mandatory minimum sentences for nonviolent drug crimes, giving judges discretion to hand down probation instead of jail time for offenses.



- <u>SB 16</u>: Allows for more types of personnel records to be subject to public disclosure including those related to excessive use of force and sustained findings of failure to intervene, unlawful arrests, and discrimination.
- <u>AB 26</u>: Requires police departments to adopt policies that mandate immediate reporting when an officer witnesses a colleague using excessive force and punishes those who do not intervene.
