AP 5030 Fees

Gloria Harrison Fisher (amendment approved 10/4/11) asked how off-campus students could purchase health insurance. Charlie Ng will follow up on Gloria's question. Charlie and Steve Sutorus are researching the enforcement of parking at the District Office.

Charlie said we need the revenue from the parking fee increase immediately. He said the budget committee assigned the parking revenues with the campus. There is no requirement that parking violation fees go into the parking budget. He said best practice is to leave the money in a non-restricted fund rather than a restricted fund, which would limit the flexibility of the funds.

Ben Mudgett moved, and Cassandra Thomas seconded a motion to give the various constituent groups an opportunity to review AP 5030 and return the AP to District Assembly in October.
