CALL TO ORDER

Jeremiah Gilbert called the meeting to order at 3:04pm.

CHANCELLOR'S REPORT

Chancellor thanked CSEA and the district for finishing their collective bargaining over their current contracts. The board approved two faculty sabbaticals for next year. Chancellor's Leadership Academy just completed the 3-day workshop with different speakers and a facilitator.

PRESIDENT'S REPORT (Status of District Assembly President)

Jeremiah accepted an interim management position at the district. Until June 30th he is the Interim District Director of Research, Planning, and Institutional Effectiveness. As such, we have to find a new assembly president. We will have the election at the December meeting to call for an election and nomination of president to serve for the spring.

APPROVAL OF 10/3/17 MINUTES

Diana Rodriguez moved to approve. Jim Holbrook seconded the motion to approve the minutes of October 3, 2017. Unanimous approval.

OLD BUSINESS

Jeremiah Gilbert pulled AP 7240 and AP 2410. The current version of AP 2410, on the website, was approved by District Assembly in March but the Board's Ad Hoc committee on policy made additional changes that came back to District Assembly. It was pulled from the Board agenda for first read and it was requested to be pulled from DA agenda. The Chancellor was asked to work with the Academic Senates. The Board was reluctant to change the language, but Chancellor said it was absolutely essential to pull it and have further collegial consultation. The Chancellor asked the body to do their best to review and decide sooner than 90 days. Perhaps it is easy language changes that would be acceptable to the faculty and still meet the intentions of the Board. Chancellor will do what is necessary to move the AP expeditiously.
