

## Program Efficacy Report Spring 2013

RTVF is a growing program at SBVC, especially in light of the new facilities KVCR provides. The program has partnered with the Fontana Unified School District and California State University to provide training and opportunities for students to:

- 1) provide extraordinary learning opportunities in the areas of radio, television, and film to high school, community college, and university students, as well as members of the SB community;
- 2) ensure that students of all ages receive the best theoretical and practical training in these media fields;
- 3) facilitate the smooth transition of students from high school to community college to 4-year universities and beyond; and
- 4) provide opportunities for job placement in the media industry and local businesses.

RTVF is right in line with the mission of the college and shows the promise of growth in many areas.

RTVF provided data regarding the program and analyzed the data. The program demographics are mostly in line with those of the college with respect to ethnicities, however with respect to gender, women are grossly underrepresented. Unfortunately, this trend is consistent with industry standards where with respect to women, RTVF has exceeded industry standards.

RTVF program adequately serves students by providing regularly scheduled classes M – Th and has currently added 3 new evening classes for Fall of 2013. There are also 3 online course and no weekend classes.

**Efficacy Team Analysis and Feedback: Meets**

RTVF boasts the highest FTES (52.03) in the last 6 years as well as the highest retention rate (86%) during the same time. The other data is respectable including WSCH and success rates. The program discussed its goals to increase the program and previous setbacks along with current plans to improve the program. The most noteworthy plan to improve the program is the 2+2+2 partnership, where students start in high school, continue on to community college and then matriculate to the university.

All courses and programs in the RTVF department have course level and program level SLOs. A rotation exists to evaluate all courses every three years. To date, minor instructional changes have been implemented at the classroom level based on SLO evaluations at the course level.

The Radio/Television/Film department provides a comprehensive instructional program in radio and television broadcasting, digital film production, and digital audio and video production for use in broadcasting, cablecasting, multimedia, film production, and Internet applications. Students may earn a certificate to begin work immediately after completion. Students are encouraged to transfer to a four-year university. This mission is in line with that of the college.

The program describes itself as enrichment for student success and has articulated with the universities how best to designate the enrichment between the three educators; high schools, community colleges, and universities. Thus, agreements have been articulated.</p>

Because of the new state of the art facility built within the last three years, RTVF is cutting edge with respect to technology. RTVF has also created the Inland Empire Media Academy to address other industry trends with plans in place to offer workshops to supplement the degree program. Enrollment has shown steady growth, increasing almost 25% over the last 3 years alone (which includes a decrease in sections offered).</p>

<p><b>Efficacy Team Analysis and Feedback: Meets</b> RTVF has several accomplishments listed including the Inland Empire Media Academy created under a directive initiated by the Chancellor. This program has in place agreements between Fontana Unified and Redlands Unified school districts along with CSUSB. Wide reaching planning with collaborations at various educational levels makes this training beneficial to all parties involved. Another accomplishment has been the production of the Student Film Showcase which provides a forum to call attention to student work from various levels. This year (2013) RTVF students will again produce the graduation video, however for the first time; it will be broadcast on KVCR-TV.</p>

Because of the expensive cutting edge equipment necessary to stay current with industry standards, it is challenging to provide education using the latest technology. Outside funding (Perkins Grant) has already been incorporated along with partnerships (KVCR) to provide the very best in educational opportunities, but finances are always a challenge. Other challenges were also mentioned.

**Efficacy Team Analysis and Feedback: Meets**

RTVF has a new building facility that is less than 3 years old which includes new furniture. The computers will be replaced this summer (July 2013) and the cameras are up to industry standards. RTVF is currently partnered with Fontana Unified School District, more specifically 3 high schools in the district, and Redlands Unified School District and is about to sign an agreement with California State University, San Bernardino to commence June 1, 2013. These partnerships include visitation from the 3 high schools in the Fontana school district to Valley College and collaborative learning opportunities several times a year. Memorandum of Understanding have been signed by Fontana Unified School District and drafted for CSUSB. These agreements are with respect to the Inland Empire Media Academy provide instruction at each level collaboratively to produce students with theoretical and practical training ready for career placement (2+2+2).
