The program meets an effective pattern of service in that it permits students to maintain full-time day jobs through the offerings of evening and Saturday courses. This is a great opportunity for individuals with day-shift positions; however, it seems this may create a barrier for individuals who work the nightshift and for single parents. This raises increased concern due to the fact that the female student body is severely underserved in this area. SBVC does provide services to many single parents, specifically single mothers. The children's center offers daycare services but only during the day. The lack of day courses may be one huge contributing factor as to why the female population is so underserved in this program.
