## 1. Renovation Request

Pharmacy Technology programs are now required to be accredited the American Society of Health-System Pharmacists, ASHP, processed by the Pharmacy Technician Accreditation Commission. To be accredited each program has stipulations to follow, including a dedicated classroom/lab. Currently the program uses Nursing classrooms at night and one of the chemistry labs. A suggested site is one of the classrooms on the west side of HLS, since the facility is the Health Science hub. The classroom would be remodeled to have on one wall a simulated retail pharmacy with shelves and counters for basic lab skills. The advance class in pharmaceutical procedures will still use the chemistry lab, but the other courses can use the renovated classroom.
