DSPS Student Rights

According to the California Code of Regulations (Title VI, the Rehabilitation Acto 1973) (Section 504), and The Americans with Disabilities Act of 1990 (ADA), youhave certain rights.

- As a qualified student with a verified disability, you have the right to receive reasonableadademic accommodations based on your educational limitations in order to have accesstd activities, programs, and services. The college faculty and staff shall not automatically reject an accommodation unless other effective, more feasible ones exits or the identified accommodations have been determined to lower academic standards or otherwise fundamentally alter the nature of the program in question.
- Your participation in DSPS shall be entirely voluntary.
- Receiving DSPS support services/accommodations or DSPS instruction shall not preclude vous from participating in any other course, program or activity offered by the college.
- All records maintained by DSPS personnel pertaining to your disabilities shall be protected from disclosure and shall be subject to the Family Educational Rights and Privacy Act (FERPA) requirements for handling student records. However, your

consentto release information is not required as long as the disclosure is to other schoologicals (including instructors) within the college whom San Bernardino Valley College as determined to have legitimate educational interests. Portions of the information of present to DSPS may be shared with the Chancellor's Office of the California Community Colleges or other state or federal agencies; however, disclosure to these parties made in strict accordance with applicable statues regarding confidentiality, including the Family Educational Rights and Privacy Act (FERPA). According to Section 7 of the Edderal Privacy Act, providing your social security number is voluntary.

 You shall not be excluded from the participation in, be denied the benefits of, or be subject to discrimination under any program or activity in a public entity. In essence, you shall not be discriminated against in any way on the basis of disability.

If you wish to file a formal complaint or grievance regarding discrimination on the basis of disability, you should contact DSPS Director, Larry W. Brunson, Jr. (909-384-8949) or the ADA/504 Coordinator Scott Stark (909-384-8958). You may also contact the US Department of Education Office of Civil Rights.

DSPS Student Responsibilities

Disabled Student Programs & Services (DSPS) receives special funding to provide servicesta students with disabilities and is required to meet state and federal regulations. To help you comply with these regulations, you, as a student receiving DSPS services, we the following responsibilities:

- to provide DSPS with documentation of your disability;
- to meet with a DSPS Counselor to complete an Academic Accommodations Plan (AAP);
- to request services that are identified in your Academic Accommodations Plan (AAP);
- to show progress toward the goals in your Academic Accomodations Plan (AAP);
- To notify DSPS in advance of any absences from class or appointments if you are using interpreters, captionists, tutors, and/or other assistants (failure to notify DSPSinght result in the loss of services);
- To return any equipment on loan from DSPS at the end of each semester (if the
 equipments not returned, you will be held responsible for replacement costs);

To maintain behavior appropriate in the educational setting; and

• To abide by the Student Code of Conduct and the Academic Honesty Policy.

Student Code of Conduct at San Bernardino Valley College

You are held individually responsible to abide by the information contained in the SBVC Catalog and by the Student Code of Conduct. Failure to read and comply with college regulations will not exempt students from whatever penalties they might incur.

You are expected to conduct yourself in an acceptable manner while on campus and when Expresenting SBVC in any off-campus activity. Policy for Suspension of DSPS Services

If you fail to follow written policies and procedures for DSPS services, the DSPSDirector will notify you in writing that you are in violation of the DSPS policies and procedures and that if you continue to be in violation, services may be suspended at terminated. You will be invited to discuss the issue in a meeting with the DSPSDIrector. A written notice will be sent to you when formal action is taken to suspend terminate services. You will also be notified of the process for appeal of a decision suspend or terminate services.
