<b>VOTING/MEMBERSHIP/QUORUM (Attachments 1, 2, 3)</b>	<p>Since the September 23<sup>rd</sup> Curriculum Committee Meeting, Mary Copeland has been in numerous discussions about voting. Though Leticia Hector provided documentation about previous voting, there was no proof of it being vetted by the Academic Senate. Regardless, this is the time to review and update designated voting members to ensure consistency with the Senate By-Laws and AP. According to the Academic Senate website (attachment 1), "Whether non-faculty members of the curriculum committee are voting members is a local decision, but regardless of this decision on voting status, curriculum remains a matter of faculty primacy. A benefit to allowing non-faculty members to be voting members is that, while curriculum is a matter of faculty primacy, the curriculum belongs to an affects the entire institution. Making the curriculum committee as inclusive as possible leaves little room for doubt that the committee is the definitive authority on curricular matters". With that being said, the curriculum committee reviewed attachment 2 titled Curriculum Committee Membership and Voting. Mary notated that many colleges require the majority of the faculty to be present for quorum in order to ensure the faculty input is not diluted. This would mean that the majority of the faculty members of the committee would need to attend the meetings on a regular basis. Currently, there are some discussions taking place at Senate to find different ways to encourage faculty to attend their assigned committees. Leticia inquired as to how many people on the committee are faculty and how many are non-</p>

	<p>faculty. After some calculation it was determined that 20 members are faculty and 4 are non-faculty. Thus, determining the need for majority faculty present would not be an issue when determining quorum. Glenn Drewes suggested keeping the voting and membership as is to showcase the inclusivity of the committee as it does not hinder the faculty driven process. There was some discussion about including the Schedule/Catalog Data Specialist on the membership, as that position never attends the meetings. Dina Humble suggested keeping that position on the committee as it provides valuable insight, but at the moment the person holding that position is still new and learning the processes. Another discussion ensued about including a Dean of Occupational as well as a manager assigned by the Vice President of Instruction. Whether non-faculty members of the curriculum committee are voting members is a local decision, but regardless of this decision on voting status, curriculum remains a matter of faculty primacy. A benefit of allowing non-faculty members to be voting members is that, while curriculum is a matter of faculty primacy, the curriculum belongs to and affects the entire institution. Making the curriculum committee as inclusive as possible leaves little room for doubt that the committee is the definitive authority on curricular matters. However, the faculty voice should never be diluted or effectively vetoed by non-faculty members of the curriculum committee. One method of preventing the dilution of the faculty voice is to establish a quorum requirement that the majority of the voting members present at the meeting are faculty, not simply 50% plus one of the voting membership. Local senates should ensure that the proportion of faculty voting members is sufficiently large to maintain faculty primacy over curriculum while maintaining inclusivity of non-faculty members in the curriculum approval process through the curriculum committee.

The leadership structure of the curriculum committee should be clearly defined. Regardless of whether the curriculum committee is chaired solely by a faculty member or has faculty and non-faculty co-chairs, such as a faculty co-chair with a CIO or a curriculum specialist co-chair, the process for selecting chairs or co-chairs should be clearly documented and established in a way that retains the local senate's purview over the selection of the faculty chair or co-chair of the committee in accordance with Title 5 §§53202 and 53203.

Additionally, curriculum committees may opt to form subcommittees for more focused work. Examples may include subcommittees that handle the technical review of course and program proposals, placement of courses in the local general education pattern, review of program and course student learning outcomes, prerequisites, honors course proposals, and local graduation requirements. The creation of subcommittees of the curriculum committee is a local decision and should be done based on local need and for the purpose of making the approval process more effective and efficient. Because of the potential for additional subcommittees to cause bottlenecks in the approval process, care must be taken to ensure that the creation of subcommittees does not unnecessarily slow the curriculum approval process. Finally, if subcommittees of the curriculum committee are established, each subcommittee should have a chair that is responsible for facilitating the work of the subcommittee and for regularly reporting the outcomes of the subcommittee's work to the curriculum committee.

#### LOCAL CURRICULUM APPROVAL PROCESSES: REVIEW, EVALUATE, AND IMPROVE

OVER 77% OF RESPONDENTS TO THE ASCCC Spring 2015 survey on Curriculum Efficiency and Communication stated that the typical time for approval of curriculum is six months or less, from submission to the curriculum committee to approval by the governing board (Appendix A). However, six months encompasses most of the academic year, and any approval process that takes longer than one primary term<sup>2</sup> of approximately three months may unnecessarily delay the availability of new curriculum to students. Ideally, as a rule of thumb, local senates should strive for an approval process

335: **The Curriculum Committee** is authorized by the Academic Senate to make recommendations to the Board of Trustees about the curriculum of the college, including approval of new courses, deletion of existing courses, proposed changes in courses, periodic review of course outlines, approval of proposed programs, deletion of programs, review of degree and certificate requirements, and approval of prerequisites and co-requisites.

The position of Curriculum Committee Chair carries no less than .58 release time for a term or three years with the possibility of a one-year extension should there be no viable candidate for the position. (revised 10/17/18)The process for electing the chair of the Curriculum Committee shall be as follows:

1. An announcement stating a vacancy in the position of Curriculum Committee Chair will be distributed to all faculty at the beginning of the spring semester (January);
2. A memo from interested faculty detailing their qualifications shall be submitted to the Chair of the Elections Committee no later than March 1;
3. The candidates will be asked to attend the next Senate meeting following the submission deadline to present their qualifications and answer any questions;
4. A vote will be taken following the presentations to select the new chair.

## **Curriculum Membership and Voting Rights**

The following excerpts are from “The Curriculum Committee: Role, Structure, Duties and Standards of Good Practice.” (1996) (state academic senate website)

### **Membership**

Title 5 §55002(a)(1) requires that the curriculum committee contain faculty. Good practice dictates that the faculty be representative of the departments or divisions of the college.

Counseling and library faculty should be part of this representative model and each should select representatives to the curriculum committee.

Key administrative functions which can assist the committee in its work include an instructional administrator, typically the chief instructional officer (CIO), and a student services administrator, typically the dean of counseling, as well as those responsible for articulation and matriculation—be they faculty or administrators. Classified participation is not specified as an area of significant effect on classified staff as detailed in Title 5 §51023.5 and so classified staff do not generally participate as members of the curriculum committee.

The exclusive bargaining agent for the faculty also has the right to negotiate representation on the committee (Title 5 §53204).

### **Currently, the committee is supposed to be comprised of the following:**

- at least 2 faculty from each division, including student development and student support
  - the articulation officer,
  - the matriculation coordinator
  - the curriculum secretary,
  - the catalog data specialist,
  - the instructional user liaison (also datatel specialist),
  - 2 students,
  - the Dean of occupational Ed.,
  - the administrative co-chair, which is the Vice President of Instruction (or the Vice President’s designee)
  - and the curriculum co-chair appointed by the academic senate.

The other issue is **voting rights**. There is not a uniform structure across the state. The following excerpts are also from “The Curriculum Committee: Role, Structure, Duties and Standards of Good Practice.” (1996) (state academic senate website)

**Voting**

Because curriculum is the primary responsibility of the faculty, the voting membership of the committee should be predominantly faculty.

The voting status of administrators who may serve on the curriculum committee is a matter for local decision as the academic senate and the Board of Trustees work cooperatively to establish the shared governance structure of the college. Students must be provided an opportunity to participate in formulation and development of district and college policies and procedures on curriculum (Title 5 §51023.7); their right to vote on the committee is determined locally by mutual agreement between the academic senate and the board of trustees.

**Currently, the voting members include the list below EXCEPT the curriculum secretary, the catalog data specialist, the datatel specialist.**

- at least 2 faculty from each division, including student development and student support
- the articulation officer,
- the matriculation coordinator
- the curriculum secretary,
- the catalog data specialist,
- the instructional user liaison (also datatel specialist),
- 2 students,
- the Dean of occupational Ed.,
- the administrative co-chair, which is the Vice President of Instruction (or the Vice President’s designee)
- and the curriculum co-chair appointed by the academic senate.

**Curriculum Committee Suggests the following changes:**

Curriculum secretary and the catalog data specialist should become voting members.

Student representatives should not be voting members.

**The Curriculum Committee is recommending that the Academic Senate approve the above mentioned changes, and request that the revised membership list, along with voting rights be identified in our Academic Senate BYLAWS.**
