<p><b>Frank Peterson to submit deletion request for ADJUS 130.</b></p> <p>At the request of Frank Peterson, Cindy Parish discussed IMPACT-CRM JUSTICE meetings she has attended and the pending legislature. The majority of the committee were in agreement with the decision at the March 24 Curriculum Meeting that, should any legislature be passed with regard to CRM JUS/ADMIN JUS, the Curriculum Committee will re-visit the issues and make determinations regarding the courses/programs at that time. Don Schall indicated that his understanding was that the CRM JUS courses recently Board approved were "pending dependent upon Cindy Parish's presentation at this meeting".</p> <p>Bob Stafford stated that the ADJUS courses, although modifications were made to the descriptions/content, should have been informational only.
