DISCUSSION AGENDA

Curriculum Training – Scott Rippy reviewed the “link” section of Curricunet with committee members. Patti provided the following handouts: Summary of Components of an Integrated Course Outline of record for Degree Credit Courses and The On-Line Curriculum Approval Process. (see attached)

Distributed Education – Scott stated that it is his understanding a course must have been updated within the last two years in order to submit for DE. Leticia Hector has requested clarification on that statement as it was her understanding that DE could be submitted if a course is within the 6-yr content review cycle. Scott stated he would check where he obtained the 2-yr information and let the committee know. Patti stated she has spoken with Linda Stevens and is awaiting her approval of the submission of DE courses for the upcoming schedule. Patti will let the committee know of Linda’s decision.

“Themed” courses (same content with different “exercises”) – There was some discussion on whether a course could be modified to include specific themes that would be listed under separate sections. The committee will discuss this further at an upcoming meeting.
