Vocational Programs: Look at individually since they transfer as a "program"

- *Limited transferability: student must check into the transferability of the course (this is put in the catalog)
- *Limited transferability (placed into the catalog)
 - o Proposed process (course must meet one of the two criteria) for determining if a course is to be numbered 100-200:
- Originator/faculty research a minimum of 3 universities for catalog descriptions similar to the proposed/reviewed course

- o "College Level": The committee agreed that there needed to be definition on the term "College Level" courses and the discussion of the possibility of recommending the numbering of these courses to be 0-99.
