- Discipline/interdisciplinary placement with Physics, Geology, Biology, Geography and History (Documents attached: Curriculum Committee Minutes from 11/5/07 outlining the discipline placement process we put in place in fall 2007.)
- Review cycle for vocation or occupational training programs (Documents attached: Ed. Code 78015-78016.5 and Section 55003): The VTEA Team Committee went through the documents in great detail and confirmed that their programs do not require content review every two years, but are on the 6-year review cycle as other campus courses and programs. What it requires is a review of items such as to whether there is still a demand, or need, for the program, how many certificates produced, etc. The VTEA Team decided to set up a committee to evaluate these items and submit a report to the VP of Instruction. A courtesy copy of the annual report will be sent to the Curriculum Committee. The Curriculum Committee's co-chairs and the Dean of CTE met to clarify, discuss and present this information to the Curriculum Committee. It was noted by a committee member and former co-chair that the 6-year review cycle has always been followed and that we should remain consistent.
