- NO REPEATABILITY: CTE, ART, FORENSICS, and P.E. NEED TO LEVEL COURSES. No more than 4 levels.
- REPEATABILITY ONLY FOR: ensemble performance and applied courses in Music, and Ensemble performance courses in Theatre and Dance.

When do we enforce at SBVC?

The Chancellor's Office tracks the enrollment in every single course we offer, could simply decline to provide apportionment for courses that don't comply by the implementation date they determine to be reasonable.
