DISCUSSION ITEMS:							
SABBATICAL:	Mary will be taking Sabbatical for the Fall 2018 semester and is asking anyone who wants to temporarily chair the committee while she is on Sabbatical to contact her directly.						
SLOS:	Mary has invited Celia Huston to attend Curriculum, so the committee will know what to look for when reviewing proposals. As discussed during the last meeting, the Committee would like to know what their prevue is in regards to reviewing SLOs. It was suggested that an SLO Coordinator could be added to the approval process, similar to the DE Coordinator. The Committee is requesting a list of criteria to review when looking over SLOs.						
CERTIFICATES:	Low unit certificates were discussed and if they are in the best interest of the students. Currently, all certificates under 18 units are not State approved, which means students cannot receive financial aid for these classes. According to Dr. Terri Long, there will be a change in Title 5 for certificates of achievement, which will be going to the Board of Governors in March. There is a proposed change to the funding formula, where it will be partially performance based. This means we will need to be able to get credit for lower unit certificates where we can show completion and success, of all programs. If this proposal is approved and adopted by the State, all certificates 16 units and above will need to submitted to the State for approval.
