	DISCUSSION ITEMS:
ENGL 914	English Department has decided based off AB 705 and guidance from the State Chancellor's Office to not offer ENGL 914 for the Fall 2019 semester, which is two levels below Freshman Composition. It will be up to the various departments who currently have this course as a requisite to decide how they would like to modify their curriculum based off their curricular needs. The English Department will be retooling ENGL 015 for FA19, which will include content from ENGL 914. Mary has provided a list of all courses with ENGL 914 as a requisite. She asked the Committee to advise departments in their respective areas about the change and how they would like to proceed with this removal of ENGL 914. If the course is articulated, they need to contact the Articulation Officer for further guidance. Dr. Long attended the CIO conference last week in Sacramento and the subject of AB705 was a topic of discussion. There needs to be a clarification as to what needs to occur between all parties at the State level.
