AB-705	The AB-705 meeting held by the ASCCC on campus on September 20 th provided further clarification on the upcoming changes needed for curriculum. If departments prefer to have requisites of lower level English or Math courses will start the clock for students. Faculty in these departments need to evaluate whether these lower level requisites are needed for a student to successfully pass a course with a 70% or higher. Departments need to have a dialogue with English and Math to see what works best for the students. Leticia will invite both departments to the next Curriculum Committee meeting.

	DISCUSSION ITEMS:
AP/BP Review	The Committee was asked to review the AP/BPs by the Academic Senate. AP 4060 is the Delineation of Functions and Agreements. This a brand new policy. The corresponding BP was approved in Spring and has been waiting for this AP to arrive before being finalized. There was some discussion on the Adult Education portion of this policy and the Committee decided Emma Diaz, AEBG Director, should review prior to finalization. BP4100 is Graduation Requirements for Degrees and Certificates. Updates to this policy are slight. Janice recommended including transfer degrees in the language. Leticia will forward the Committee's comments to the Academic Senate.
Work Experience	The Work Experience proposals being reviewed by the Committee follow the District's Cooperative Work Experience Plan. This plan was submitted to the State Chancellor's Office in 2000. According to the plan we need to have an employer that will host our students and will come up with objectives an employer assigned supervisor and a faculty instructor. At the September 10 th Curriculum Committee meeting, there was much discussion about the SLOs. Dr. Terri Long provided some samples for the Committee to choose from. The Curriculum Committee recommended the following SLOs for Work Experience Courses (098s): These SLOs were then forwarded to Faculty Chairs, Instructional Deans, and the Committee on September 19 th . The courses below received approval from the Faculty Chairs, with exception to BUSAD, which requested to use a different set of SLOs. Courses highlighted in RED were added after the agenda was sent out.
