The Curriculum Committee recommends that the pre-requisites and co-requisites approved be re-evaluated in the next 2-3 years by the appropriate departments/programs to ensure student success.							

DISCUSSION ITEMS:

ENGL Course Repetitions The Articulation Officer voiced the following concerns: There is currently a duplication of content (greater than 50%) in the English lower level courses in comparison with the transferable ones with the same title. The courses (lower-level and transferable) are identified as different courses because they each have unique prerequisites, however they are currently being instructed in the same day/time scheduled class meeting. These issues alone could jeopardize our general education articulation with California public four-year universities. It should also be noted that although the content of the courses are deemed the same, students have the option of completing both the lower-level and transferable courses, in which the units (3+3=6) are applied toward the required 60 units needed to receive an SBVC Associate Degree. Many of these courses were last modified in 2012, prior to the State Chancellor making changes to repeatability. Per Title 5, section 55041, the English courses in question do not qualify as a" type" of course that can be repeated. The English Department will take this matter to their faculty and Mary will be meeting with Dr. Long to discuss all options prior to the Full Committee Meeting.
