The instructor would hold synchronous office hours for DE students using the following tools: Zoom, Canvas Chat, White Board through zoom if needed. The instructor also accepts calls, texts, and emails from all students. In this course the instructor can also meet with the students face to face during the face to face lab time.

- 6. Provide a specific example of how this course's design ensures regular and effective instructor-student contact? (Ex: Threaded discussion forums, weekly announcements, instructor prepared materials, posting video and audio files, timely feedback on exams and projects, synchronous online office hours, synchronous online meetings, synchronous online lectures, etc.)**

Weekly announcements, threaded discussions, weekly zoom recorded lectures and or synchronous meetings, weekly synchronous office hours will be posted on the syllabus, exams, and projects (group and individual), timely feedback on all assignments, exams, and projects. The instructor will also post power points and instructor prepared material. This course is a hybrid course that will have the lecture portion and some of the lab portion online and some of the hands-on lab portion face to face. This is because of COVID-19 and the fact that we must abide by the social distancing rules until further notice.

- 7. Provide a specific example of how this course will ensure regular and effective student-student contact? (Ex: Threaded discussion forums, assigned group projects, threaded discussions, Notebowl, peer-to-peer feedback, synchronous online meetings, etc.)**

Student to student contact will be done through threaded weekly discussions, one group assignment per course, Peer to peer feedback with threaded discussions as well as synchronous online meetings. Students are encouraged to work together on case studies each week and complete the study questions. Students are also encouraged to study for exams in groups.

- 8. Describe what students in this online version of the course will do in a typical week on this class. Include the process starting after initial log in.**

A typical week for students will be to login to Canvas, check announcements, complete any discussions, projects, assignments the instructor has posted. The student will check in with the instructor via the online synchronous meetings that will occur twice a week, listen to online lectures that have been pre-recorded, and communicate with other students via the discussion boards and peer to peer evaluations. Students will complete designated assignments and submit. The instructor will grade submissions and give feedback directly to the students. If students are working on a group project, there will be communication between the student group. If students need assistance or clarification from the instructor, they may make an appointment to meet with the instructor during office hours or contact the instructor via email or by phone.

This course will require the assigned textbook, a laptop or computer or smart phone with video capabilities. In this online course it is important to stay connected and engaged. This course requires students to check in weekly to view new and relevant information concerning deadlines, due dates, online course discussions and other information concerning this course. This course will require the use of San Bernardino Valley College's web-based canvas platform. You will automatically have access to the Canvas platform. There will be video chats, messaging through various platforms, email, canvas, chat, zoom, there will several sessions of group discussions and interaction with the instructor scheduled throughout the course. It is up to you to stay current with the assignments and materials. I am always there to help you with any issues you might have. Synchronous office hours will be scheduled daily during set hours. If you are not able to attend office hours you may email your questions or concerns, and I will get back to you within 24 hours.

The face to face lab portion of this course will require Black pants-(not jeans), a white chef Jacket with SBVC Culinary Arts Program logo, a black chef's hat, non-slip shoes, a white kitchen apron and a black bib style apron. These items are mandatory for the face to face lab portion of this course.

### 10. Provide a specific example of how regular and effective student-student interaction may occur in this online course.

Students are expected to work with other students on the group project weekly. Student interaction will also occur during synchronous online meetings. Discussion boards will also be a source of student to student communication. There are discussion boards on a weekly basis.

### 11. Provide a specific example of how regular and effective instructor-student interaction may occur in this online course.

Students will receive feedback, at least 3 to 4 times a week, such as after every quiz, and when portions of the projects are due. Students will have access to the instructor every day, and the instructor will respond that day also or within a 24-hour period.

### 12. Does this course include lab hours? No Yes – If yes, how are you going to accommodate the typical face to face activities in an online environment?

The lab hours will be mostly face to face. The lab hours that are not held face to face will be done by students completing projects at home, recording the project and sending it to the instructor.

### 13. How will you accommodate the SLO and Course Objectives in an online environment?

The same way I would in a face to face course. The curriculum is set up to include all SLO and Course Objectives in a way to incorporate student success. Each module of the course will include Course Objectives and at least one SLO. The information given in an online course needs to be laid out so that the student can follow and grasp concepts that might be explained differently in a face to face meeting. The face to face lab meetings will also help achieve the current SLO's and Course Objectives.
