Although MUS 141 does not involve student-student contact by nature (the class is private lessons), the design of MUS 141 could incorporate weekly Discussions with required prompts for regular and meaningful student-to-student engagement with other students in the instructor's studio, the use of breakout rooms during Zoom sessions, and other tools (such as Flipgrid) which the instructor may wish to use to ensure regular and effective student-to-student interaction.

8. Describe what students in this online version of the course will do in a typical week on this class. Include the process starting after initial log in.

Students will access their MUS 141 course through the LMS and be directed to a main page of necessary tasks, either in the form of a To-Do list, Weekly Announcement, or other directive. The course will be divided into Modules or sections which correlate to the syllabus. Each week, content material presented and assignments required will correspond with the course description, outcomes, and objectives. The student will be able to play or sing a selection that demonstrates major and minor scales—chosen by the instructor, and will be able to identify the stylistic differences of music compositions from these periods: medieval, renaissance, baroque, classical, romantic, and modern— either synchronously or asynchronously per the instructor's preference. Given the content, it is reasonable to require weekly assignments, discussions and/or peer review of material and recorded performances, and weekly or regular assessments through quizzes and exams. Some third party sources may be used by the instructor to supplement learning, i.e. the A Capella app, Flipgrid, GarageBand, etc.

I will be posting Announcements weekly on our upcoming Lessons, Assignments, and Assessments. Upon submission of Assignments, the student may expect feedback within 7-10 business days through the form of private comments using the comment tool in the LMS. Students may also message directly through LMS messenger or email questions or concerns, which will be responded to by the instructor within a 24-hour period.
