- b. This initiative establishes in state constitution a system of independent pubic community college districts and Board of Governors. Generally, requires minimum levels of state funding for school districts and community college districts to be calculated separately, using different criteria and separately appropriated.
- c. Allocates 10.46 percent of current Proposition 98 school funding maintenance factor to community colleges. Sets community college fees at \$15/unit per semester; limits future fee increases.
- d. It also provides formula for allocation by Legislature to community college districts that would not otherwise receive general fund revenues through community college apportionment.
