## **SSCCC Basic Skills Resolution**

The SSCCC addressed potential topics of resolutions to sponsor at the Spring 2009 General Assembly. This was addressed at the SSCCC Council meeting on Saturday,

February 7<sup>th</sup>, 2009. I suggested that we sponsor a resolution that would eliminate or increase the maximum units allowed for basic skills courses within Title 5. I drafted the following resolution pending approval of the SSCCC Council:

WHEREAS, according to the California Community Colleges System Office, the total number of seats consumed in "Basic Skills" courses in Spring 2008 were 135,696; only 71.57% were retained although merely 51.04% succeeded. Furthermore, the total number of seats consumed in Basic Skills Courses in Winter 2008 dwindled to 17,033; considerably 88.13% were retained and 71.47% went on to be successful in the courses.

WHEREAS, Cal. Admin. Code tit. 5, § 55035 declares that, "...no student shall receive more than 30 semester units (or 45 quarter units) of credit for remedial coursework....'remedial coursework' refers to nondegree-applicable courses..."

WHEREAS, many community college districts specify twenty-two (22) courses or less as "Basic Skills" courses. In addition, a majority of these courses are three (3) units. As a result, countless numbers of students easily surpass the 30 semester unit threshold and are then "restricted to taking only noncredit courses, nondegree-applicable courses which do not involve remediation, and those degree-applicable credit courses which do not have prerequisites or advisories on recommended preparation." Cal. Admin. Code tit. 5, § 55035

WHEREAS, Cal. Admin. Code tit. 5, § 55035 does state that "the governing board of a district may provide a waiver of the limitation on remedial coursework with respect to any student who shows significant, measurable progress toward the development of skills appropriate to his or her enrollment in degree-applicable credit courses...". However the wording "...may provide a waiver..." is ambiguous and does not guarantee students the opportunity to access such a waiver.

**THEREFORE LET IT BE RESOLVED THAT**, Cal. Admin. Code tit. 5, § 55035 be amended to allow California Community College students to receive no more than 45 semester units (60 quarter units). Further amendments include the removal of the ambiguous word "may" to be replaced with "shall" so that we, the 2.7 million community college students, are guaranteed the right to obtain a waiver from our district if we show significant, measurable progress.

**THEREFORE LET IT BE RESOLVED THAT**, the Student Senate for California Community Colleges work with the California Academic Senate to urge the Board of Governors, Consultation Council, and all statewide boards, committees, and ad-hoc groups to incorporate the amendments stated above into the Cal. Admin. Code tit. 5, § 55035.
